AUTHORISED SIGNATORIES & CONTACT DETAILS FORM	This form should be completed in its entirety by the Section 151 officer or Chief Financial Officer, who is responsible for the payment of LGPS31 contributions (they must also sign LGPS31 form).	Access form	Access form
LGPS 31	Certificate of Pension Contributions. This form is for employers to confirm that contributions have been deducted and payments made to the scheme in accordance with the scheme's requirements.	Access form	Access form
LGPS 5A*	Notification of starter. This form is for employers to notify East Sussex Pension Fund of new pension scheme members. Form LGPS-I completed by the employee on commencement of employment should be enclosed with this form.	Access form	Access form
LGPS 8A*	This form should be used to notify East Sussex Pension Fund of a pension scheme member who is leaving the scheme early and will not be entitled to immediate benefits.	Access form	Access form

LGPS IH – 4B	Request for review of a tier 3 ill-health award. Suspended pensioner who left employment after 31 March 2014 REASON: Review requested by pensioner whilst pension is in payment or within 3 years of payment being discontinued and before normal retirement age.	Access form
LGPS IH – 4C	Request for review of a tier 3 ill-health award. Suspended pensioner who left employment after 31 March 2014. REASON: Review requested by pensioner 3 or more years after cessation of payment and before normal retirement age.	Access form
